I am so thankful that we are going to have a new District Attorney in Humboldt County. I have been a very vocal critic of the policies implemented by Paul Gallegos during his time in office. I know that there is a large segment of our population that believes marijuana is a very minor drug and shouldn't be illegal. The thought process is that it really doesn't harm people or cause them to put other peoples lives in danger like alcohol does. Before our lenient marijuana laws were in place there were people who went to prison for what some considered very minor offenses.
