I am adamantly opposed to Measure Z. If this Measure passes, it will increase the sales tax in Humboldt County. There are other sales tax proposals on the ballot for individual cities as well. There are 384 employees who are making over \$100,000 per year of your tax dollars, 4 are making over \$300,000, 22 are making over \$200,000 and 81 are making over \$150,000.
