The Humboldt County property tax bills have been mailed to the current owners and it is a good time to review how ridiculously out of hand our elected officials have been when it comes to taxing us into oblivion. Yes, we are overtaxed. The bond initiatives are passed blindly by the voters without any thought as to what the money is going for. The reason we pay property taxes, sales tax and income tax is to first fund our schools, police and fire departments, public works and then we need to take care of those less fortunate. The system is all screwed up. We spend over half our budget on welfare type programs which leaves the essential services with budget deficits. The people in charge are afraid to cut back on the freebies for fear of losing the next election because there are more people with their hand out than there are people with there hand in a work glove. The next line is a Humboldt Fire Assessment 1985 for a total of \$84.00 and then another Humboldt Fire Assessment 2004 for a total of \$168.00. These hidden taxes that are billed through my property tax bill total \$1,138.34. The actual property tax bills, which are supposed to fund our schools police and fire departments total

\$8,952.44 before the additions that push my bill to over \$10,000 on a piece of property my family paid \$400 for back in the early 1880's. Multiply this by the thousands of property owners in Humboldt County and it is easy to see that we don't have a revenue problem, we have a spending problem. The money that is being wasted right before our eyes should sicken all of us. If you are a property owner, you know how ludicrous the situation is. If you do not own property and are a renter, these fees, assessments, bonds and taxes are passed directly on to the amount of money you pay for rent. Yes, these taxes hurt the poor more than anyone else. In the next election, and every election going forward, we will be asked to open up our wallets to keep public safety and education financially solvent. Before you blindly vote for these increases, please remember that the budgets are in the condition they are in because of gross mismanagement, not because there is a lack of funds. If you are a renter, these tax increases are the reason your rent gets raised, not because some greedy landlord is lining his own pockets. I have a friend who is so disgusted, that after measure Z passed, she started buying as many of her taxable goods in Oregon when she visits her family.
